**SECOND READING TO ORDINANCE #2011-002, (FORMALLY ORDINANCE #2010-015), AN ORDINANCE TO ESTABLISH NON-RESIDENT FEES FOR THE DELIVERY OF FIRE SERVICES AT THE SCENE OF MOTOR VEHICLE ACCIDENTS:**

Mr. Chris Altman, Director, Emergency Services, came before council regarding Ordinance #2011-002. Mr. Altman stated that there are more 911 calls that require the fire department to answer. He stated that based on council's challenges to raise revenue, non-residents who travel through the county are not being charged. Folks will not be charged if the services are not used. Council Member Phillips asked wanted to know how would they be billed. Mr. Altman stated that they will have to provide proof of insurance; if they do not have insurance, then they will bill the individual. Mr. Altman explained that the billing would be in-house. **Moved** by Council Member Haulsee, seconded by Council Member Phillips, to give second reading to Ordinance #2011-002 (Formally Ordinance 2010-015), An Ordinance to Establish Non-Resident User Fees for the Delivery of Fire Services at the Scene of Motor Vehicle Accidents. **ADMINISTRATOR'S REPORT:**

**Recommendation on Amending the Housing Municipal Inmates Agreement**

Administrator Graham reported that Mr. Jerry Cook came to the February 22 council meeting and asked council's consideration of amending the Housing Municipal Inmates Agreement with the towns to allow a period of forty-eight (48) to seventy-two (72) hours before the \$25 fee would be imposed. She stated that council asked her to provide a recommendation in response to this request. Administrator Graham recommended that council leave the Housing Municipal Inmates Agreement with the towns as is with a period of twenty-four (24) hours allowed before the \$25 (twenty-five dollars) is imposed. She stated that she has spoken to Mayor Goodwin, and he had no great concern. Chairman Gray stated that council has already factored in the revenue to have a balanced budget. Administrator Graham stated that there has not been enough time to see how the agreement is working. Council Member Haulsee stated that he would like to give the agreement time to see how it plays out. By general consensus, council accepted Administrator Graham's recommendation for the agreement to remain as is.
