**RESOLUTION TO PROVIDE FOR THE APPOINTMENT OF THE REPRESENTATIVE OF HAMPTON COUNTY TO SERVE AS A COMMISSIONER ON THE GOVERNING COMMISSION OF THE LOWCOUNTRY REGIONAL WATER SYSTEM:**

Administrator Graham stated that Chairman Gray has agreed to serve. **Moved** by Council Member Phillips, seconded by Council Member Haulsee, to appoint Hugh B. Gray, Chair, Hampton County Council, to serve as a Commissioner on the Governing Commission of the Lowcountry Regional Water System Board as a representative of Hampton County. Motion carried unanimously. Council Member Williams asked about the wording in Section 2 of the resolution in which the Lowcountry Regional Water System would have the authority to sell, lease, etc. Administrator Graham explained that she believed that this would pertain to equipment, etc. when the System would attain the municipality assets, etc. She stated that the Lowcountry Regional Water System Board would have the authority to do so. Council Member Haulsee reported that he had questions about the rates. Administrator Graham explained that all the rates would be the same for all the customers under the system. She explained that the rates would not go up immediately, but they would go up.

Council Member Haulsee stated that he met with Administrator Graham and they felt that a facilitator was not needed since it was a gathering of information. Council Member Haulsee reported that he spoke with Mr. Chad Westendorf, Chair, CPST Commission, and Mr. Westendorf stated that he would facilitate the forums, if needed. Council Member Williams stated that he felt that the request was decided at the meeting on January 9, 2012 and the Hampton County Council Process Committee was to bring the request to council and request that council fund the cost for a facilitator for the CPST Commission. He stated that the commission needs to be present to listen to the people.

**Moved** by Council Member Haulsee, seconded by Council Member Phillips, to not pay for a facilitator for the Capital Projects Sales Tax Commission Forums. Motion carried with Council Members Gray, Haulsee, Johnson and Phillips voting in favor and Council Member Williams voting against. Council stated that they did not think that a facilitator was not needed but not to fund one at the county's expense.
