**UPDATE FROM THE CAPITAL PROJECTS SALES TAX (CPST) PROCESS  
COMMITTEE:**

Council Member Haulsee updated council regarding the Capital Projects Sales Tax forums. Council Member Haulsee stated that they held the last forum on January 30<sup>th</sup> and received a lot of input. He stated that the commission was not going to review projects until the project deadline which is February 16<sup>th</sup>. He stated that the commission will meet on February 22<sup>nd</sup>. Mrs. Frannie Heizer, Legal Advisor for Capital Projects Sales Tax, informed the commissions of the purpose, duties, and also that the amount of years that the sales tax could be collected was eight (8) years instead of seven if the amount as stated in the referendum was not met. Administrator Graham asked the Process Committee to ask the commission to please approve the minutes from their meetings so that she could get a copy of them.

**ADMINISTRATOR'S REPORT:**

**Request from the Hampton County Historical Society to Request Permission to Conduct Structural Study**

The Hampton County Historical Society requested from Council permission to conduct a study using funds from the Hampton County Historical Society. Permission is needed from the county, because Hampton County is the owner the property, Hampton County Museum. **Moved** by Council Member Phillips, seconded by Council Member Haulsee, to approve the request from the Hampton County Historical Society to conduct a structural study of the Hampton County Museum using funds from the Hampton County Historical Society. **Request from Sheriff Smalls for the Additional Part Time Funding Until Reimbursable Funding is Received:**

Sheriff Smalls came before council to request additional part-time and funding for par-time help. He stated that the funds to cover the part-time workers has been delayed but will be received. He requested that council cover the cost of the part-time workers discussed until the funds are received. **Moved** by Council Member Phillips, seconded by Council Member Williams, to allow the sheriff to keep the number of part-time employees until the sheriff receives his money to reimburse the county. Motion carried unanimously.

Chairman Gray requested that the County Administrator get with the Clerk to Council to get the clerk a copy machine that is most feasible for her.
