He expressed that since Mr. Sullivan stated that the problems reported pose safety issues for seniors. Council thanked Mr. Sullivan. Chairman Gray asked Administrator Graham to get Mr. Hodge and Mr. Hiers to look into the matter. Administrator Graham addressed Mr. Sullivan to state that Mr. Sullivan has not been kind to staff.

MR. JOHNNY ALLEN, CITIZEN, REGARDING JONES AVENUE:

Mr. Johnny Allen came before council to state that his road is not being maintained. He stated that his wife is sick and has nerve problems. He stated that it is a shame. He stated that he came at an earlier meeting and was supposed to be contacted. He stated that he was told that his road is private property and has not received an answer back from anyone. He stated that he brought the deed showing that the road was not private.
