**LEWIS HARDISON, MEMBER, HAMPTON COUNTY AIRPORT COMMISSION:**

Mr. Hardison came before council and stated that he has been a resident of Hampton County since 1984. He informed council that the airport is a great for the county and need to restore. He commented that if the county built the hangars then you would have people based here. Mr. Hardison can get high school students interested in aviation and can get the Civil Air Corps to come in and use the airport to transport animals to no kill shelters. Council thanked Mr. Hardison for his comments.

**MS. RHONDA HARDISON:**

Ms. Hardison commented that she did not need to speak; Mr. Lewis Hardison was her husband, and he said everything that she was going to say.

**COUNCIL MEMBER RONALD WINN:**

Mr. Winn commented that the agenda is to be posted 24 hours working days, but should be posted Wednesday. Would like to see situation corrected.

**MR. QUINCY JONES:**

Mr. Jones expressed to council that he is in support of the airport and its expansion. He commented that he did not think the county should proceed until the litigation is over. He read from the deposition from Jim Daniel who was the Economic Development Director for Hampton County in which he said the county had given permission for Company Two to use the airport; Mr. Jones expressed that this is why he is frustrated and will be going to court in the next 4-6 weeks.

**MR. RAY WARD, HAMPTON COUNTY AIRPORT COMMISSION:**

Mr. Ward came before council and provided his credentials as a military pilot and commercial pilot. Mr. Ward informed everyone that he owns his airport and from his native home he learned to fly on a grass runway. He doesn't need an airport, because he has his own, but the county does need the airport.

**MS. BARBARA GRAY:**

Ms. Barbara Gray came before council and expressed that she is not against the airport but against the loan of \$2,666,620. Ms. Gray stated that council said that millage hasn't gone up, but she said that taxes have. Ms. Gray said that she lives on a fixed income, and if the proposed plan to pay back the loan does not come through, it will come out of the citizens' pocket. Ms. Gray provided an example of her vehicle taxes as to how much she was paying on a 2001 vehicle but it came down after she questioned it.

**MR. CHUCK PLATTS:**

Mr. Platts came before council and stated that this is not to take away funds from education or parks and recreation. There will be twenty hangars. There will be tenants, and a there is a waiting list for tenants. He explained that there is a minimum threshold to get federal funding.

Mr. Chip Mixson stated that he has been a resident in Hampton County since 1987. He commented that an airport without a hangar is just an airstrip. He explained that with the industry; the county takes one step forward and two steps back. Mr. Mixson wanted to know what is the total monthly revenue that the hangars will bring in. Also, he wanted to know what the fuel sales are? Mr. Mixson explained that this is benefiting only a few citizens, a hobby – as long as you want to play, you need to pay.

**MR. DARRYL RUSSELL, TOYS FOR TOTS:**

Mr. Russell came before council to explain that he is the coordinator for the Toys for Tots. He reiterated that Patriot's Pizza made a donation and there was a private donation of \$2,500 in toys from a private donor. He asked permission to put brochures on the stand in the hallway.

**MR. NIGEL ALEXANDER:**

Mr. Alexander commented that may help to discuss how long the contracts are? He explained that it may fall back on every citizen. Mr. Alexander also expressed concern regarding the plane coming in and out; he checked the numbers and the plane was from Jasper County.
