DISCUSSION OF THE HAMPTON COUNTY RECREATION DEPARTMENT'S BUDGET (MR. DOBIE HIERS, HAMPTON COUNTY BUILDING AND GROUNDS SUPERVISOR AND HAMPTON COUNTY RISK MANAGER):

Mr. Dobie Hiers, Hampton County Building and Grounds Supervisor and Hampton County Risk Manager, came before the Hampton County Parks and Recreation Advisory Commission (HCPARAC) to explain the recreation department's budget and answer questions regarding recreation that the HCPARAC had. Mr. Hiers explained the budget to the members and provided information regarding the programs offered. Ms. Long had some questions regarding the Nature Trail. Ms. Hiers explained that repairs are needed to the bridge. He will get the information and get back to the commission. Ms. Lawton had a question regarding liability of recreation with a swimming pool. There was a discussion of offering swimming for youth and seniors. Mr. Anderson gave some input as to what Beaufort County does in regards to its recreational swimming program. There was a short discussion regarding ideas for the next proposed penny sales tax specifically for the recreation department. Ms. Long explained that the commission members can research some ideas to discuss at the June meeting.
