The above listed came before council individually to convey their objection to the #2,666,620 General Obligation Bond and some regarding the desire for council to focus their efforts on recreation, the item listed in the Capital Projects Sales Tax list and council's needs assessment list. Some citizens questioned the Capital Equipment Financing that passed in 2016 for 10-T hangars for \$275,000. Information was requested for the cost of the 20 proposed hangars and the two commercial hangars and the amount that the fuel is bringing in and the cost of the fuel and what revenue is being earned by the county. Citizens also wanted what was the lease amount for the hangars monthly. The Administrator replied that it was \$210 per month. Also, there was a question if there were any lawsuits pending regarding the airport. It was stated that there were no lawsuits. Also, citizens cited that the county had a proposed deal that did not come to fruition regarding the medical helicopter in which the loan was acquired to buy a building. They expressed their concern that if the revenue is not produced as anticipated, then the citizens would be the ones who will be responsible for repayment of the loan. Citizens reiterated their desire for council to remember their needs assessment priority and CPST priority. Chairman Bishop closed the public hearing.

**MS. EDNA ALLS REGARDING RECREATION:**

He explained that every toy collected and every dollar collected stays in Hampton County and any public space available for the storage of the collections is needed. Council thanked Mr. Russell for his service.

Ms. Busby came before council and expressed her disdain regarding the clarity of the answer to her question regarding if the county had a lawsuit pending. She explained that Ms. Elliott and council were not truthful in responding to the public when asked if there was a pending lawsuit regarding the airport. County Attorney Solomons advised the council and administrator not to comment.
