HAMPTON COUNTY DEMOLITION GRANT RESOLUTION:

Moved by Vice Chairman Phillips, seconded by Council Member Smith, to adopt the Hampton County Demolition Grant Resolution which will address the need of the demolition of obsolete buildings and vacant, dilapidated residential structures to address and support crime prevention efforts in targeted LMI neighborhoods has been identified as a priority community need for Hampton County; by making application to the South Carolina Department of Commerce, Division of Grants Administration for Community Enrichment, Hampton County at the completion of this project would benefit approximately 130 persons, of which at least 51% qualify as having low-to-moderate incomes. The proposed project areas are: the incorporated areas near Early Branch and Varnville. Hampton County Council authorizes the County Administrator to prepare and submit a Community Development Block Grant (CDBG) Community Enrichment Application for the Hampton County Demolition Project, to commit local cash/in-kind match in the amount of 10% of total grant amount to meet the matching commitment of the Community Development Program, and to commit to sharing cost savings on a pro rata basis. Motion carried with Council Members Hollingsworth, Phillips, Smith and Williams voting in favor and Council Member Winn voting against.
