Chairman Bishop opened the public comments for the third reading to an Ordinance to Approve Amendment of the Agreement for Development of a Joint County Industrial Park, By and Between Hampton County, South Carolina and Colleton County, South Carolina, Providing for the Development of a Jointly Owned and Operated Industrial/Business Park, so as to Include Additional Property in Colleton County as Part of the Joint County Industrial Park. **((Colonial Precast Concrete of Carolina, LLC))**. There were no public comments. Chairman Bishop closed the public hearing.

**PUBLIC COMMENTS**

Chairman Bishop informed the public that 5 minutes would be given to each speaker for a total of 30 minutes.

**MR. JOHN RHODEN REGARDING AIRPORT HANGARS:**

Mr. Rhoden came before council and informed council that he was speaking on the matter of the airport hangar dilemma. He explained that he does not support or support the project. He told council that now is not the time for Hampton County to go into a debt of about 3 million dollars. He stated that he rides the area of Hampton and Varnville in the mornings that is just something that he does. He explained that there are a total of 18 businesses that have closed. He continued that people of our county has not seen the projects for the 1% sales tax, CPST for all the projects materialize. He further stated that the Town of Hampton has been supporting the recreational efforts for baseball and soccer and the Town of Varnville for football. Mr. Rhoden requested from Administrator Dobson Elliott a synopsis of money collected and requested. Administrator Dobson Elliott responded that she will get it for Mr. Rhoden tomorrow. Mr. Rhoden what were the plans for the Administrative Center and when will it be done. He exclaimed that it was a shame for the county's Administrative Center to look like this. He said he was here two times last week and there were leaves on the porch and a board with 3 nails sticking up. Chairman Bishop that the Administrative Center is the list but the Recreation Complex is next on the list and projects can't be skipped over. Administrator Dobson Elliott commented that the windows have been repaired.

**MR. CHARLES HAWKINS REGARDING THANKS:**

Mr. Hawkins stated that he lives in Hampton County twice. He was here as the Associate Warden with the prison and when they retired, he and his wife looked around and decided that they wanted to live in Hampton County, South Carolina. He told council that people are watching you at all times. He stated that as a voter and resident of the county, he wants to thank the council for what they do.

**MR. CHUCK PLATTS REGARDING AIRPORT:**

Mr. Platts came before council to say that there was a lot of to about not receiving federal funding; he explained that there is a threshold that has to be reached to receive federal funding. There have been at least 10 aircraft hangars before able to get federal funding. Will not get 2.6 million dollars and parks and recreation will not pay for itself, the airport will help to enlarge the tax base and provide aviation training for the youth, etc.

**MR. JACK WOODWARD REGARDING AIRPORT:**

Mr. Woodward explained that he has been on the Airport Commission for many, many years and has been in aviation for about 60 years. He explained that they have put a lot of thought into this and hate that most people are “naysayers”. He cited that Walterboro, Allendale and Jasper just 30 million dollars from the federal government and hate to come every time and hear negative comments. He commented that this project needs consideration.

**MR. RAY WARD REGARDING AIRPORT:**

Mr. Ray Ward commented that Mr. Jack Woodward invited to a lot of stuff and he was appointed to the commission. He explained that he has contributed physically to this project by running machines and now the earthmoving and site is ready. This commission has volunteered for many hours.

**MR. JACK BRODERSEN REGARDING AIRPORT:**

Mr. Brodersen came before council and stated that he is a recent resident. He commented that in the year 2018 3.4 million of economic activity is for Hampton County is due to the airport. He also explained that Hampton County sets in a dead zone for aircraft services. He explained that this is a great opportunity for the county.

**MS. RHONDA HARDISON REGARDING LIGHTING:**

Ms. Hardison came before council and commented that she was concerned about the lighting. There needs to be better lighting as you walk up the sidewalk, steps of the building. Someone needs to look into it; we all are getting older and need to see to get to cars when leaving the meeting.

**REV. GUY HODGE REGARDING CHURCH BUILDING:**

Rev. Hodge, Representative for Second Baptist Missionary Baptist Church, came before council and commented that they have been trying to erect a building for approximately two years and are having issues. He reported that the building that they are erecting sits about 3 feet on Short Wave Lane which DOT (Department of Transportation) says sits is out in the middle of nowhere. He reported that the Codes Enforcement explained that the building is about three feet on the road. Rev. Hodge and others came and asked for assistance in resolving the matter.

**MR. DeKELLY PITTINGER:**

Mr. Pittinger came before council and commented that he is not against the airport hangar project but is concerned about the timing. He explained that he too would like to see businesses come into Hampton County. Mr. Pittinger reported that he checked with Jasper County about how much they were charging to rent their hangars; he reported that Jasper County was charging \$600 per month to rent a hangar. He commented that Hampton County would be charging like \$210 per month. Mr. Pittinger reiterated that he thought that if the project was going to pass, then the county needed to get more per month. Mr. Pittinger expressed concern that now was not the right time for the county to get in debt.

Administrator Dobson Elliott responded to Mr. Pittinger that she does not get a vote; those council members think for themselves.
