**TREE CLEARING BID:**

Administrator Dobson-Elliott presented the tree clearing bid at the airport. She identified the area and explained that the state will reimburse the county for the clearing of these trees as long as the lowest bid is accepted. If the lowest bid is not accepted, then the county will have to pay the difference of the bid accepted and the lowest bid. **Moved** by Council Member Williams, seconded by Vice Chairman Phillips, to accept the lowest bid of \$58,778 (Fifty eight thousand, seven hundred, seventy eight dollars). Council Member Winn wanted to know what was going to be done with the trees. Administrator Dobson-Elliott explained that the sawmills do not take trees from yards. She explained that they will be hauled to the landfill and may grind them and use in the landfill for covering. Council Member Winn asked that the county make sure that they have the signatures from the residents before removing the trees. Administrator Dobson-Elliott commented that this is a part of the process. Motion carried with Council Members Bishop, Hollingsworth, Phillips and Williams voting in favor and Council Member Winn voting against.

Administrator Dobson-Elliott presented the second tree cutting bid. **Moved** by Council Member Hollingsworth, seconded by Vice Chairman Phillips, to award the tree cutting bid to Ansley Tree Cutting for the amount of \$12,500 (Twelve thousand, five hundred dollars). Council Member Winn explained that they can be sold for biofuels, etc.
