abandonment – SCDNR (South Carolina Department of Natural Resources) Palachucola Wildlife Management Area. He explained that the road closure is being requested by SCDNR which involves the dirt road that has been maintained by the County that traverses the Old Palachucola Club property in southern Hampton County. Mr. Crosser explained that SCDNR wanted to take over the maintenance of the road and that it would continue to be open except for hunts and impassable travel during inclement weather. Council thanked everyone for the presentation.

**THE HONORABLE JIMMY BILKA, MAYOR, TOWN OF HAMPTON, REGARDING RECREATION:**

Mayor Bilka, Town of Hampton, came before council and shared with them the many things that the Town of Hampton is doing in regards to recreation and programs for youth sports. Mayor Bilka explained that the Town of Hampton is experiencing upgrades and repairs to recreational facilities above the cost of keeping the programs and facilities in good condition. He explained that there is a cost in excess of \$4,000 that the Town of Hampton has; he commented that he has done everything and coming to the county for help is the last resort. He asked the county if at all possible he would appreciate any appropriation to assist with these cost. Mayor Bilka explained that all children that play come from all over Hampton County.

**Budget Calendar**

Administrator Dobson-Elliott presented the 2019 Budget Calendar to council. **Ms. Suzanne Peeples, Director, Emergency Management, Regarding Pocotaligo Road Update**

Ms. Peeples came before council to provide an update regarding the Pocotaligo Road. Ms. Peeples explained that she was in a meeting with Mr. Gosnell, South Carolina Department of Transportation (SCDOT), and was told that the funding has been approved but there is one more letter to be signed. The road should be open before the end of the year. Council thanked Ms. Peeples for her report.

**Dr. Wilcox, Hampton County School District #1, Regarding Possible Collaboration with Technical College of the Lowcountry and Hampton County Airport Commission Regarding Aviation Program**

Administrator Dobson-Elliott presented to council the possibility of funding being available for someone to come in and have an Aviation Flight School and offer to the community. She asked Dr. Wilcox to come and share the conversation that they had regarding the matter. Dr. Wilcox explained that when he was in Tennessee, the school, his Air Force ROTC instructor was a pilot and together they put together a program for students to get their pilots license, etc. He explained that many of those students are flying commercial flights, etc. Also, he explained that with the technical college, there could be many jobs connected to aviation on the mechanical side.

Council thanked Dr. Wilcox. Administrator Dobson-Elliott explained that to go after the funding, she needed a letter of support from council. **Moved** by Vice Chairman Phillips, seconded by Council Member Williams, to authorize the Chairman to sign a letter of support for the grant from the Aeronautics Commission for the aviation class. Council Member Winn asked that council be provided a copy of the letter before it is sent. Motion carried unanimously. Administrator Dobson-Elliott explained that this will be no expense for the county.
