**PUBLIC COMMENTS**

**COUNCIL MEMBER WINN REGARDING CONCERNS:**

Council Member Winn informed council about matters regarding the airport and the cutting of the trees in the neighborhood, the clean-up with leaving stumps in the yards, and noise from aircraft coming in and out of the airport. Council Member Winn commented that Chairman Bishop should be reprimanded for sending an e-mail without contacting council regarding his challenging of the house member's appointment regarding the airport. Council Member Winn commented that he has asked for USDA loan information from 2015 on money collected and who spent it. He explained that Dr. Hollingsworth spoke about the council had an agreement but would like to know where that money went and how it was allocated. Council Member Winn commented that he's requested information under the Freedom of information Act and never properly responded for investigation.

**MR. ARTHUR RUTH:**

Mr. Ruth came back before council and wanted to know when his road would be paved at Brookwood; the county said that it would be paved, but it has not. He explained that they have been there since 1994. Mr. Ruth was told that this does not fall under council's purview. The Transportation Committee sets what roads are paved. Administrator Dobson Elliott will check into the matter and contact Mr. Ruth.

**MR. DON BRANT:**

Mr. Don Brant came before council regarding prayer for Yemassee. He explained that they will be assembled in Yemassee and Hampton County as a whole on Tuesday, January 21, 2020, at Fletcher's Café. He explained that they meet at Fletcher's Café every Tuesday morning at 7:00 a. m. to pray for the government, Fennell Elementary, and teachers. Mr. Brant quoted, 2 Chronicles 7:14, "If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land."
