ORDINANCE(S)

SECOND READING TO 2020-013, AN ORDINANCE TO AMEND THE MASTER QUAD COUNTY MULTI-COUNTY PARK AGREEMENT TO REFLECT A NEW DISTRUBUTION OF ALL FEE PAYMENTS FOR FUTURE PARK MEMBER DEVELOPMENT IN HAMPTON COUNTY, WHEREAS HAMPTON COUNTY WOULD EARMARK A PORTION OF FUTURE FEE PAYMENTS FOR THE FOLLOWING SPECIFIC ITEMS: 20% - PROPERTY TAX RELIEF, 15% - ESTABLISHMENT OF AN ECONOMIC DEVLPMENT FUND, 3% - INDUSTRIAL PARK MAINTENANCE AND 2% - COUNTY RECREATION.

Moved by Council Member Bishop to approve Ordinance 2020-013, 2020-013, An Ordinance to Amend the Master Quad County Multi-County Park Agreement to Reflect a New Distribution of Fee Payments for Future Park Member Development in Hampton County, Whereas Hampton County Would Earmark a Portion of Future Fee Payments for the Following Specific Items: 20% - Property Tax Relief, 15% - Establishment of an Economic Development Fund, 3% - Industrial Park Maintenance and 2% - County Recreation. The motion died for a second. **Moved** by Vice Chairman Williams, seconded by Council Member Alexander, to table the matter until the second meeting. Motion carried with Council Members Alexander, Hollingsworth and Williams voting in favor, and Council Member Bishop voting against.

ADJOURNMENT

Moved by Council Member Bishop, seconded by Council Member Williams, to adjourn. Motion carried unanimously. Chairman Phillips adjourned the meeting.
