Hampton County Council held a regularly scheduled meeting on Tuesday, January 19, 2021, 6:00 p. m. Council Member(s) present: Charles H. "Buddy" Phillips, Chairman; Darin Williams, Vice Chairman; Roy Hollingsworth, Clay Bishop, and Noah O. Alexander. Council Member(s) absent: None. Staff present: Rose Dobson-Elliott, Administrator, Aline Newton, Clerk to Council, A. G. Solomons, Jr., County Attorney. Staff absent: None. Wilson Holland, Hampton County IT Director was present. The meeting was advertised as prescribed by law.

Vice Chairman Williams explained that he wanted it removed to further discuss, but council already have a standing committee already, and he felt that you don't have to create another one. Also, he said that council did not come up with the selection of persons to serve. Council Member Hollingsworth explained that the Hampton County veterans served their county and falls in line to create or establish a veteran's memorial park. **Moved** by Vice Chairman Williams to delete Item 9.1; there was no second. The motion died for the lack of a second. Administrator Dobson Elliott stated that Mr. Danny Black, SCA, has requested that 7.2 be on the next agenda; 7.2 be deleted. **Moved** by Council Member Bishop, seconded by Vice Chairman Williams, to eliminate Item 7.2. Motion carried unanimously. **Moved** by Council Member Bishop, seconded by Council Member Hollingsworth, to adopt the January 21, 2021 county council consent agenda and meeting agenda. Motion carried unanimously.

**APPROVAL OF MINUTES**

**JANUARY 4, 2021 HAMPTON COUNTY COUNCIL MEETING MINUTES:**

**Moved** by Council Member Bishop, seconded by Council Member Williams, to approve the January 4, 2021 Hampton County Council Meeting Minutes as presented. Council Member Alexander asked if the vote count for the election of officers for the January 4, 2021 meeting could be included. Council Member Hollingsworth said he needed changes on page 1 of 3 under Adoption of Agenda to remove the word “virtual” and to change the spelling of his daughter’s name from “Alana” to “Alanna.” Council Member Hollingsworth commented that he had one more correction. On page 3 of 3, it read, “Moved by Vice Chairman Williams, seconded by Council Member Alexander, to table the matter until the second meeting. Motion carried with Council Members Alexander, Hollingsworth and Williams voting in favor, and Council Member Bishop voting against.” He commented that the minutes reflected that it was a 3 to 1 vote.

Council Member Hollingsworth wanted to asked Chairman Phillips if he voted. Chairman Phillips reported that he did not vote; it was a three to one vote. Because it was not a tie, he did not have to vote to break a tie. Council Member Hollingsworth commented that the Hampton County Guardian was incorrect; Council Member Hollingsworth informed council that the paper said that the vote was 4 to 1. He wanted to know who provided them with the incorrect information. Chairman Phillips said that Council Member Hollingsworth wanted to know how the paper reported something that did not actually happen at the meeting. Council responded that they did not know. Council Member Bishop stated that he would **retract** his original motion and **move** to approve the minutes with the corrections; it was seconded by Council Member Williams. Motion carried unanimously.
