MRS. MARIE ELLIS, CURATOR, HAMPTON MUSEUM AND VISITOR'S CENTER (HMVC), REGARDING THE PROPOSAL FOR MICROFILMED HISTORICAL MINUTES:

Mrs. Ellis came before Council and made a recommendation to Hampton County Council to provide the Hampton Museum and Visitor's Center (HMVC) a copy of the original (1888 - 1904) minutes of the county's microfilmed minutes when completed. She stated that the HMVC would pay Joyce Hallenbeck \$500 (five hundred dollars) to have the minutes typed. She stated that a copy of the typed minutes will be available from the HMVC at a cost of \$15.00 (fifteen dollars) per copy. She stated that this will include a loose leaf notebook and each typed sheet sleeved. She stated that anyone may purchase this copy. Mrs. Ellis stated that the HMVC would provide the county library and county museum a copy at no charge. She stated that this would not be bound or sleeved but ready for both. **Moved** by Council Member Bowers, seconded by Council Member Wilson, to accept the recommendation. Motion carried.
