**BIDS**

**BIDS FOR HORIZONTAL BALER:**

Administrator Graham stated that the Finance Director and the Recycling Manager (Bid Committee) met and reviewed the bids. She stated that they recommended the lowest bidder, Southeasterern Environmental Waste Equipment, for a bid of \$38,266 for the Horizontal Baler. **Moved** by Council Member Wilson, seconded by Council Member Bowers, to award the bid to the company that was recommended by the bid committee which is the lowest bidder, Southeastern Environmental Waste Equipment, in the amount of \$38,266 (thirty-eight thousand, two hundred sixty-six dollars). **ADMINISTRATOR'S REPORT:**

**Courthouse Plans as Recommended by Buildings and Grounds Committee**

Administrator Graham stated that the Building Committee (Lee S. Bowers and Peggy Parker) met on November 16, 2006 with the Architects. Mr. Smith, Moseley Architects, gave a brief presentation. Council Member Bowers stated that it was the recommendation of the Building Committee to move forward with the courthouse project and to let bids in January. **Moved** by Council Member Bowers, seconded by Council Member Wilson, to go forward and let bids in January 2007. Motion carried unanimously.

**Extension of Lease Agreement for the Veterans' Affairs Office**
