ORDINANCE #2007-013, TO AMEND THE CODE OF ORDINANCES BY PROVIDING FOR THE ASSESSMENT OF AIRCRAFT SUBJECT TO PROPERTY TAX IN HAMPTON COUNTY; TO ESTABLISH THE ASSESSMENT RATIO OF THE FAIR MARKET VALUE OF SUCH AIRCRAFT:

Moved by Council Member Wilson, seconded by Council Member Johnson, to give third (3rd) reading to Ordinance #2007-013, an ordinance to amend the code of ordinances by providing for the assessment of aircraft subject to property tax in Hampton County; to establish the assessment ratio of the fair market value of such aircraft and to reduce the assessment rate from 10.5% to 4%. Motion carried unanimously.

ORDINANCE #2007-014, AN ORDINANCE TO DEVELOP A JOINTLY OWNED AND OPERATED INDUSTRIAL/BUSINESS PARK IN CONJUNCTION WITH COLLETON COUNTY, SUCH INDUSTRIAL/BUSINESS PARK TO BE GEOGRAPHICALLY LOCATED IN COLLETON COUNTY AND ESTABLISHED PURSUANT TO SOUTH CAROLINA CODE OF LAWS OF 1976 4-1-10, ET. ESQUIRE AS AMENDED (BY TITLE ONLY):
