**ADMINISTRATOR'S REPORT:**

**Purchase of Property**

Administrator Graham stated that the property is a duplex located behind the library with a total square footage of 1,240. She stated that the request is for council to approve the purchase of this property from Mr. Lee Cope at a sales price of \$60,000 cash and a tax deduction of \$45,000 and for council to authorize the county attorney and the county administrator to close the transaction. **Moved** by Council Member Phillips, seconded by Council Member Wilson, to purchase the property (duplex located behind the library with a total square footage of 1,240) from Mr. Lee Cope at a sales price of \$60,000 cash and a tax deduction of \$45,000 and to authorize the county attorney and the county administrator to close the transaction. Motion carried with Council Member Parker abstaining. Council Member Parker stated that she left the room during all discussions of this matter. She stated that she did not truly have a conflict of interest, but Mr. Cope and her husband were business partners, and she did not want any perception of a conflict of interest. She stated that she nor her family will gain from this sale.

**South Carolina Department of Transportation Adopt-An-Interchange Grant for  
Interchange Improvements for Exit 38 of I-95 in the Town of Yemassee**

Administrator Graham stated that Hampton County has been awarded a grant of \$150,224 with a required match of \$37,556 to enhance the only entrance from I-95 (Exit 38) to both the Town and County. She stated that :

- a joint application was made by the Town of Yemassee and Hampton County for this grant with the understanding that the matching funds would be equally provided \$18,778 each agency
- South Carolina Department of Transportation did not want to issue a joint award. They preferred instead to make the award to one agency and have a local agreement made between the two parties
- Hampton County must agree to the terms of the SCOT Participation agreement for implementation of the grant and enter a local agreement with the Town of Yemassee for matching funds and long term maintenance. The County is responsible for honoring this agreement if others do not.
- A copy of the grant award and draft of the local agreement has been provided by Mayor Goodwin. A response is anticipated soon.

Administrator Graham recommended that council enter into an agreement with the Town of Yemassee for matching funds and long term maintenance of the site and to accept the grant award pending agreement with the Town of Yemassee. Council Member Parker wanted to know why the financial impact was stated as “\$18,778 up to \$37,556”. Administrator Graham stated that the county would be responsible for the full match if an agreement was not reached. **Moved** by Council Member Wilson, seconded by Council Member Johnson, to enter into an agreement with the Town of Yemassee for matching funds of \$18,778 up to \$37,556 and long term maintenance of the site and to accept the grant award of \$150,224 (one hundred fifty thousand, two hundred twenty-four dollars) pending agreement with the Town of Yemassee. Motion carried.

**Hampton County Recreation Department Receives \$30,000 Grant from CSX Railroad**

Administrator Graham announced that the Hampton County Recreation Department received a grant from CSX Railroad in the amount of \$30,000 (thirty thousand dollars) for recreation projects in the towns of Estill, Scotia and Yemassee.
