**BID FOR COUNCIL ON AGING TRANSPORTATION SERVICES:**

Mr. Meyer came before council and stated that council is being requested to award the bid for the Council on Aging Transportation Services. Mr. Meyer stated that bids were solicited as required; bids were reviewed by the Director of the Council on Aging, the Council on Aging Advisory Board and the Finance Director. He stated that the agreement is for the 2010 calendar year with the option to renew for up to four (4) one (1) year periods. He stated that the funding will be provided by the Department of Transportation. Mr. Meyer stated that the bids were as follows: (1) Lowcountry Regional Transportation Authority (LRTA) for \$3,240 (three thousand, two hundred forty dollars) per month and (2) Caring Coach, LLC for \$5,000 (five thousand dollars) monthly. Mr. Meyer stated that the recommendation from the Council on Aging Director, Council on Aging Advisory Board and the Finance Director is to award the contract for transportation services for the 2010 calendar year to the current service provider and apparent low bidder, Lowcountry Regional Transportation Authority (LRTA). **Moved** by Council Member Phillips, seconded by Council Member Johnson, to approve the low bidder as presented. Motion carried unanimously.
