Administrator Graham presented the resolution regarding the renovation and expansion of the Estill Library. The resolution authorizes the County Administrator to prepare and submit a Community Development Block Grant (CDBG) Application for the County Library Project and to commit funds in the amount of 10% (ten percent) of the grant request and authorizes the County Administrator to commit an additional \$574,570 (five hundred seventy-four thousand, five hundred seventy dollars) in funds to meet the budget needs of the September 20, 2010 Community Development Block Grant (CDBG) proposal. Administrator Graham stated that if the Capital Projects Sales Tax does not pass, then council can decline the grant. **Moved** by Council Member Johnson, seconded by Council Member Haulsee, to approve the resolution as presented.
