**ADMINISTRATOR'S REPORT:**

**4<sup>th</sup> Quarter Year End Financial Report Presented as Information for the 2011-2012 Fiscal Year**

Mr. Mike Meyer came before council to present the fourth (4<sup>th</sup>) quarter year-end financial report as information for the 2011-2012 fiscal year. (See Attachment #2)

**New Countywide Employee Orientation Program**

Mrs. Connie Schroyer, Administrator's Administrative Assistant, came before council to present the new countywide employee orientation program. Council thanked Mrs. Schroyer for her presentation.

**Mr. Ernie Washington, Sr., Coroner, Regarding Vehicle Repair**

Mr. Washington came before council to inform council that a deer ran in the side of his vehicle when answering a call. He explained to council that he was in his personal vehicle. At present, he stated that he did not have a car to drive. The Administrator allowed him to use the car that is being used by the Tax Collector's Office over the weekend, but the Tax Collector's Office needed it back on Monday. Mr. Washington explained that the personal vehicle that he was in was his lead funeral car, and a funeral was scheduled in a couple of days. He wanted to know the procedure for the county to repair his vehicle. Council Member Phillips responded that the County should pay the deductible if Mr. Washington filed with his insurance company, because he was working on county business. Council Members agreed. Council asked what kind of vehicle was it. Mr. Washington stated that it was a 2003 Chevy Suburban. It was discussed if the claim could be filed on the county's insurance since Mr. Washington was on county business. Administrator Graham responded that the Insurance Reserve Fund responded that they would not cover it. Council asked and the County Attorney asked the reason that they declined covering it. He stated that the Administrator should get it in writing the reason why the Insurance Reserve Fund would not cover the claim. Administrator Graham responded that she would do so. The County Attorney explained that he would have to find out the exclusion terms, etc. Council asked if there was a vehicle that the Coroner could use. Administrator Graham stated that she would check with the Sheriff's Department. The coroner stated that Richland County had a vehicle that they had taken out of service for \$3,500 (Thirty-five hundred dollars). He stated that the vehicle was in good shape. Council asked Administrator Graham to look into the matter regarding transportation for the Coroner. **Moved** by Council Member Williams, seconded by Council Member Haulsee, to get temporary transportation for the Coroner and explore the matter regarding Richland County vehicle. Motion carried unanimously.

**EXECUTIVE SESSION**

Chairman Gray asked if the Administrator still needed the executive session regarding a personnel matter. Administrator Graham responded that she did not.

**ADJOURNMENT**
