**Council Member Hollingsworth**

Council Member Hollingsworth thanked the Administrator Graham for having the Gullah Geechee Cultural Heritage Corridor Wayfinding Sign installed and sending the advertisement and notification to the commission. He also stated that he had an opportunity to go around the county and look at roads that were reported. He stated that he visited six locations so that he could better address citizens' requests regarding these roads as to which roads get rocked and which roads get paved. He stated that there was no type of signage at 4 of the 6 roads that he visited. Council Member Hollingsworth stated that the only way that he found the roads were due to his knowledge of the county as an Extension Agent with Clemson for thirty plus years. Council Member Hollingsworth stated that visiting the roads give you a different perspective than just looking at maps, etc.

**Council Member Williams**

Council Member Williams wanted to know if all council members had received document A1-207. Council responded that they did. Council Member Williams stated that he wanted to make it clear that if a document referred to another document; then council needed to have a copy of the document that is being referenced. He asked Administrator Graham two questions: (1) On the RFP, was low bid a requirement? Administrator Graham responded that it was not. (2) Was local bid a requirement? Administrator Graham responded that it was not. Administrator Graham wanted to elaborate on her answers but Council Member Williams responded that he only wanted a yes or no answer. Council Member Williams stated that he would be attending SCAC's Mid-Year Conference. Council Member Williams stated that he wanted to give a huge thanks to the county employees and others who helped during the ice storms. He stated that it is a thankless job.
