The meeting was advertised as prescribed by law.

ADOPTION OF AGENDA

Moved by Vice Chairman Phillips, seconded by Council Member Hollingsworth, to approve the agenda. Motion carried unanimously.

Moved by Council Member Williams, seconded by Vice Chairman Phillips, to appoint Shelia Bowers to the Hampton County Tax Appeals Board. Motion carried unanimously.

ORDINANCE(S)

THIRD READING TO ORDINANCE 2014-003, HAMPTON COUNTY 2014-2015

FISCAL YEAR BUDGET:

Chairman Gray stated that council has been wrestling with the budget and the financial predicament. Council discussed various solutions to approval of a balanced budget. After the discussion, **it was moved** by Council Member Hollingsworth, seconded by Vice Chairman Phillips, to approve the 2014-2015 Hampton County Fiscal Year Budget as amended, removing the 2% cost of living increase for the employees, removing of the capital equipment line item and also doing away with the proposed Solid Waste Disposal Fee. Motion carried with Council Members Gray, Phillips and Hollingsworth voting in favor and Council Member Williams opposing. Council Member Williams stated that he

could not vote for not giving the employees a raise. Council Members Gray, Hollingsworth and Phillips stated that they would like to give the raise but did not have the revenue to do so this year.
