TO THE LOWCOUNTRY REGIONAL WATER SYSTEM (LRWS):**

**Moved** by Council Member Hollingsworth, seconded by Council Member Williams, to give second reading to Ordinance 2014-010, Ordinance to Transfer Property and Infrastructure in the Lowcountry Regional Industrial Park (LRIP) to the Lowcountry Regional Water System (LRWS) with the inclusion of the reverter clause and the deletion of the sale of property, because if the water system no longer exist under the name in which the property is transferred; the property would revert back to Hampton County. **Council Member Hollingsworth**

Council Members Hollingsworth stated that he spoke with Representative Bill Bowers regarding the SCAC's request regarding local government funding, and Representative Bowers stated that he was in support of full funding. Council Member Hollingsworth stated that he even had Representative Bowers to sign the form and he has sent it to SCAC. Vice Chairman Phillips stated that he would like a letter written to each legislator to see to find out how they feel about the local government funding. He stated that he would like know what the consensus is. County Administrator Graham will contact the legislators. Council Member Hollingsworth also discussed the Hampton County Guardian's "Letters to Editor" from Mr. Rusty Hiers about the Recycling Center Site and the recycling bins and the inability of elderly or special needs individuals to be able to dump their garbage. Council Member Hollingsworth stated that citizens should not have to go through what was stated in the editorial to dump garbage. Council Member Haulsee said that it is a learning process. The compactors are filling up on the three days and don't know when the bins are dumped. He stated that it is a change for everyone. Administrator Graham is going to get with staff to address some of those issues.
