**MS. BARBARA GRAY AND MOTHER OF THE LATE JOHN JARRELL REGARDING
PLACEMENT OF HER NEPHEW'S NAME ON ALL WARS MEMORIAL:**

Ms. Gray came before council and was upset, because she was told that the names would not be placed on the monument until December, 2015. She stated that the family would like the name placed on the monument either by Memorial Day or July 4th. She stated that they have turned in all the paperwork and was told that the committee was awaiting the completion of paperwork by another family who has a relative who was killed in the 9/11 attack. She stated that it has been five years and they would like to see his name on the monument. Ms. Jarrell stated that he enlisted

after graduation and after five (5) tours, he was killed. She stated that they received assistance from the Tragedy Assistance Office in Fort Benning, Georgia to complete the paperwork. He gave his life for his country. Chairman Williams stated that council would like to have the All Wars Advisory Committee at the next meeting. Council Member Haulsee stated that he didn't care what it cost; he would like to see the names on the monument.

MS. BARBARA GRAY REGARDING THE LOWCOUNTRY REGIONAL WATER SYSTEM (LRWS):

Ms. Gray stated that property was supposed to be transferred to the LRWS. She stated that she does not want the property transferred. The property belongs to the people of Hampton County not Lowcountry Regional Water System and their associates. She stated that if it were transferred and for some unforeseen reason automatically give to subsidiaries – “consolidating in other areas”. She stated that they were told that if they were within 300 (three hundred) feet of the road and don't want to hook into the system, they would be charged \$36 (thirty-six dollars) per month. Council Member Phillips stated that eventually there will be a water system. Council Member Phillips informed Ms. Gray that the towns were having problems with their systems.
