Hampton County Council held its regular meeting on Monday, May 4, 2015, 6:00 p.m., Council Chambers, Hampton County Administrative Center, Hampton, South Carolina. Council Member(s) present: Shedron Williams, Chairman; Christopher B. Haulsee; Roy Hollingsworth, Vice Chairman; Charles H. "Buddy" Phillips, and Isaac Smith. Staff present: Rose Dobson-Elliott, Interim Administrator; and Jo Ann Lamprecht, Economic Development. Media present: The Hampton County Guardian. The meeting was advertised as prescribed by law.

**CALL MEETING TO ORDER**

Chairman Williams called the meeting to order.

Moved by Council Member Haulsee, seconded by Council Member Smith, to come out of executive session at 6:48 p.m. regarding a personnel matter and move forward with items on agenda. Motion carried unanimously.

**PUBLIC HEARING(S)**

**ORDINANCE 2015-003, ORDINANCE TO RESCIND ORDINANCE 2014-010, ORDINANCE TO TRANSFER PROPERTY AND INFRASTRUCTURE IN THE LOWCOUNTRY REGIONAL INDUSTRIAL PARK (LRIP) TO THE LOWCOUNTRY REGIONAL WATER SYSTEM (LRWS):**

Chairman Williams opened the public hearing to receive public comments on Ordinance 2015-003, Ordinance to Rescind Ordinance 2014-010, Ordinance to Transfer Property and Infrastructure in the Lowcountry Regional Industrial Park (LRIP) to the Lowcountry Regional Water System (LRWS).

**MR. EARL FREEMAN** came before council concerned that if the county transfers the property in the Lowcountry Regional Industrial Park to the Lowcountry Regional Water System and it loses money, the customers in the system will have to share the loss and bills will increase.

**MR. RONALD "BREEZE" WINN** addressed council with a list of questions and concerns pertaining to the Lowcountry Regional Water System.

**MR. BILL HAGER, CHAIRMAN ECONOMIC DEVELOPMENT COMMISSION**, stated he is in favor of transferring the property and infrastructure to the Lowcountry Regional Water System because the equipment is a liability to the county. He further stated it will be easier for LRWS to receive grants to maintain the system if they own it.

**MR. HENRY TUTEN, COUNCIL MEMBER TOWN OF VARNVILLE**, confirmed the Town of Varnville is a member of the Lowcountry Regional Water System and he said joining was a good decision for the town.

**MR. "J. J." JINKS, COUNCIL MEMBER TOWN OF YEMASSEE**, confirmed the Town of Yemassee is a member of the Lowcountry Regional Water System and he said they joined because on paper the town's system looked good, but it was in trouble.

**MS. BARBARA GRAY**, stated that people in the country are not in favor of the Lowcountry Regional Water System because in the future they would be required to tie into the system if water/sewer lines are run in the rural areas.

**MR. BRIAN BURGESS, MANAGER, LOWCOUNTRY REGIONAL WATER SYSTEM**, stated he wanted to bring the discussion back to the issue at hand, which is transferring the property and infrastructure in the Lowcountry Regional Industrial Park to the Lowcountry Regional Water System. He addressed the concerns voiced by citizens and ended by saying that the Lowcountry Regional Water System is part of the team in Hampton County and they are not demanding to tie on or take over system assets.

**DANIEL ANDERSON, COUNCIL MEMBER TOWN OF YEMASSEE**, shared the same concern as Mr. Freeman and Mr. Winn about water bills increasing to support the Lowcountry Regional Industrial Park.

**SHERYL DELOACH, EMPLOYEE AT LE CREUSET OF AMERICA**, responded to a concern from a member of the public about the future of LeCreuset of America in Hampton County relative to water service in the Lowcountry Regional Industrial Park. She stated the company is vested in Hampton County.

Council Member Phillips stated transfer of property and infrastructure in the Lowcountry Regional Industrial Park to the Lowcountry Regional Water System is a great opportunity for Hampton County to grow and work regionally. If this is not taken advantage of now, it will set the county back.

**MS. MARY ANN DUNCAN REGARDING BIG MAMA'S ROAD** asked when the .2 mile of road will be condemned so it can be graded. Interim Administrator Dobson-Elliott told Ms. Duncan she will call her Wednesday.
