reported that \$25,000 was saved on the repair of the roof on the Administrative Building which can go back to do additional repairs on the Administrative Building. Vice Chairman Hollingsworth asked if there were any leaks that would occur in the next ten years, who would be responsible if it were manufacturer's defect. Mr. Brunson stated that if it was a defect on the manufacturer's defect, then the manufacturer would have to fix. He explained that the statute of limitations is seven years and if a limb falls or other, then the owner has to fix. The cause of the damage would have to be determined to determine the responsible party. Vice Chairman Hollingsworth stated that he did not equate savings with quality. Mr. Brunson stated that they met with county officials on Thursday regarding the bids for the Library. He reported that the plans are in the hands of the Town Building Inspector. He stated that it should be the middle of August for the ground breaking ceremony. Vice Chairman Hollingsworth asked about the cost appearing twice. Mr. White stated that one was for the lay out and the other flood elevations. He stated that there were several parcels in which the surveyor had to do work and will be combined into one parcel. Administrator Elliott stated that the Request for Bids were advertised in SCEBO and the Hampton County Guardian. Chairman Williams reported that he was told that the Pre-Bid was not mandatory, but SCEBO listed that the Pre-Bid was mandatory. Mr. Brunson and Administrator Elliott assured that it was not mandatory.
