Mr. Brantley Strickland, Project Manager, Southern Carolina Alliance, informed council that there is a projection of 45 jobs and could be up to 60 jobs. He stated that they hope to be up and running by January or February of 2018. Chairman Hollingsworth closed the public hearing.

Chairman Hollingsworth opened the public hearing to receive public comments on third reading To Further Amend the Amended and Restated Master Agreement for the Establishment of the Quad-County Industrial Park I, Park II, and Park III, By and Among Hampton County, South Carolina, Allendale County, South Carolina, Bamberg County, South Carolina, and Barnwell County, South Carolina, Providing for the Development of a Jointly Owned and Operated Industrial Park, So as to Include Additional Property in Hampton County as Part of the Quad County Industrial Park. Mr. Brantley Strickland, Project Manager, Southern Carolina Alliance, explained that this would allow the property to go into the industrial park. He stated that the host county would get 91% and the other counties would receive 1%. Council Member Williams wanted to know what would happen if a county wanted to pull out. Mr. Strickland stated that can get that answer for him. Attorney Solomons stated that there is a claw back in the ordinance. Chairman Hollingsworth closed the public hearing.

Council Member Williams asked that it be moved. He commented that they should start over large parcels should start over and get environmental impact studies – gas leaks and possible contamination noted in Phase I and he wanted to know what Phase II was He further commented that there was no study of soil, water and air for property,. He stated that council is responsible for the citizens of Hampton County and was elected to have the

citizen's best interest at heart. Council Member Phillips responded that this is not the responsibility of council. This is between the property owner and the company. Council Member Williams responded that it was due diligence of the council on behalf of the citizens. Administrator Dobson-Elliott commented that for clarification, the revenue splitting can be done for the right properties. Mr. Nash, Resident, wanted to state that he had property near the solar farms and had concern. Ms. Barbara Peeples came and voiced her opinion on behalf of the citizens. She asked why wasn't citizens given more information, she stated that she saw the signs but not knowing what it all entailed. She informed council that she researched the matter and wanted to know what the effects would be to the water, air and soil and the socio-economic impact. Council Member Phillips responded by saying that these are issues that have been hashed out. Council Member Winn stated that it was for special interest groups. Walter Smith of Tallahassee, Florida, Engineer on behalf of Citizens, informed council that the projects come under the concept of economic development but the possibility of jobs and training were few. He explained the various Phases and also that the county had the responsibility to the people. Chairman Hollingsworth responded that he thought that all council members were concerned about the people. Chairman Hollingsworth closed the public hearing.
