Altman, Hampton County Emergency Services Director, met with Yemassee Town Officials regarding the county taking over the Yemassee's Fire Department. Administrator Dobson-Elliott stated that she would draw up an ordinance in order for them to come under the Hampton County Fire Department. She stated that this action would increase the value of a fire mill. Council Member Phillips stated that when they last met with the Town of Yemassee regarding this request, they were supposed to get that straight regarding the Bender Hall area. He stated that Hampton County would not be liable. He stated that the Town of Yemassee was supposed to get that to Hampton County before the request to take their fire department was accepted. Council would like to see this in writing. Attorney Solomon will check into the matter.
