Council Member Winn inquired about Hampton County being an evacuation county. Ms. Peeples responded that there are classroom trainings for elected officials. Council Member Williams stated that the County needs to come up with some solution like using the Set Off Debt Collection through the South Carolina Association of Counties for collecting or whatever method that is available to the county. Administrator Dobson-Elliott reported that this is through the Auditor and the Tax Collector. Chairman Hollingsworth wanted to know if the county was legally entitled to the money owed to us. Council Member Williams stated that the same businesses pay the taxes in other counties but not Hampton County.
