Because of the COVID-19 lockdown, some residents, particularly those who receive mail in PO boxes, may have not received a notice from the U.S. Census Bureau yet. However, ANY household can fill out their short, easy and secure Census information by visiting [www.2020Census.gov](http://www.2020Census.gov) or by calling 844-330-2020.*

*It only takes a few minutes and it contributes so much to the county. Responses to the 2020 Census shape decisions about how billions of dollars in federal funds for critical services flow into communities like ours each year for the next 10 years. These services include healthcare, emergency response, school and education programs, roads and bridges and so much more.*

After speaking with County Officials, District leaders, and the gracious blessing from our wonderful Clerk of Court Mrs Melinda Nettles, we will display yard signs of our Seniors around the Courthouse grounds for all to see. This opportunity will be offered to Wade Hampton, Estill High and Patrick Henry. We realize that some schools may have already done something at their schools and we understand. If any of the schools would like to participate, we welcome everyone. This is #HAMPTONCOUNTYSTRONG. Below is the information.*

*We will be partnering with Ink farm Shirts and Signs out of Walterboro in making yard signs to display around the Hampton County Court House. The owner, Hunter, has offered a double sided, picture included, with your choice of saying for \$10. Each parent will be responsible for ordering their Senior a sign with the given information. The deadline to order a sign will be May 18th. This will ensure that Hunter has enough time to make all signs by May 31st. My self and other volunteers will then put the Senior signs around the Courthouse. The signs will remain up till June 8th. Each parent will be responsible in picking up their sign from the court yard. After the 8th of June I will be collecting the signs and you have to contact me to retrieve your sign. Any sign not claimed by June 12th will be disposed of. Attached to this will be a flyer with Hunter's information and ordering information on there. Please follow the steps to order your sign. After you order if you will send me a message, text or email so that I can put you on the list and be sure that your sign is picked up.*

*Again, parents will have the information to order the sign and give there child's information. Each parent will be responsible for ordering and paying. There will be no monies exchanged through me and this will not be a fundraiser. It will simply be an individual order. Myself and those that wish to help will only be responsible for putting them out that night before June 1st, and responsible for picking up any that is left after June 8th.*
