It was explained that there was no charge for the first and second calls but if there were a third and the person could prove that they had tried to correct a faulty alarm; there would be no charge, but if there was nothing done to correct a problem with an alarm, and there was a third call, then they would be charged. Council Member Bowers stated that he could not see who would be opposed to this ordinance. Administrator Graham stated that the ordinance was not intended to collect money. She stated that it was there to stop the false fire alarm calls. There were no public comments. Chairman Parker closed the hearing.
