Lowcountry Regional Industrial Park (LRIP) Wetlands Master Plan

She stated that the county contracted with Hussey, Gay, Bell and DeYoung and their subcontractor Newkirk Environmental to identify the wetlands and develop an overall master plan for the entire Park. Health of Trees on Courthouse Grounds

Administrator Graham stated that she received a copy of the report from the Forestry Commission regarding the health of the trees on the Courthouse grounds. She stated that the report indicated that the trees may be reacting to the construction. She stated that there were some recommendations as to how to treat the trees. Administrator Graham wanted to know if council wanted the opinion of another professional regarding the trees. Council Member Parker stated that she would like an arborist to look at the trees. **Moved** by Council Member Parker to hire a certified arborist to review and inspect the courthouse vegetation (trees). There was no second. The motion died for a second.

Personnel Request from Sheriff's Department

Sheriff Smalls requested the hiring of a person to substitute for the Courthouse Security Position. He stated that a retiree holds the position of Courthouse Security which is a part-time position. He stated that the retiree can only earn so much during the year. He stated that the funds are in the budget to pay the substitute. **Moved** by Council Member Johnson, seconded by Council Member Phillips, to approve the sheriff's request. Motion carried unanimously.

Hampton County Grants Administration – Grant Awards from Stimulus Funds

Mike Meyer, Hampton County Finance Director, came before council and presented a list of the grants that Hampton County has received from the stimulus funds. He stated that these are non-match grants, and they have totaled approximately \$900,000 (nine hundred thousand dollars).
