**REPORTS TO COUNCIL**

**ADMINISTRATOR'S REPORT:**

**Change Order for B. T. DeLoach Building Project**

Administrator Graham asked that Change Order #3 in the amount of \$3,382 was for three items (1) to replace very old electrical panels that could no longer be used. She stated that the electricians purchased one panel and the county purchased one. No labor was charged on this item, (2) Adding power and electrical receptacles in the break room and the demo kitchen, (3) Furring out wall and installing gypsum board in conference room. She stated that Change Order #4 for \$6,445 included seven items. Most of this expense for \$4,498 was due to unforeseen conditions of the old building, adding electrical boxes in the concrete block walls and adding wire mold. Other changes totaled \$1,947 to allow proper building use including light for the flag pole, light in the data closet, an exterior light at the rear entrance door, wire mold for power and data in the voter machine storage and the repainting of the sign out front. Administrator Graham stated that they have been very pleased with this project having only a few change orders. She reported that all the change orders totaled \$31,272 (thirty-one thousand, two hundred seventy two dollars); she informed council that \$14,689 (fourteen thousand, six hundred eighty-nine dollars) of that will be reimbursed to the county from SCE&G's Energy Wise Program. Administrator Graham stated that this brings the actual change order total to \$16,583 (sixteen thousand, five hundred eighty-three dollars). **Moved** by Council Member Haulsee, seconded by Council Member Williams, to approve the Change Orders #3 and #4 in the amount of \$9,827 (nine thousand, eight hundred twenty-seven dollars) for the B. T. DeLoach Building Project. Motion carried unanimously. (See Attachment #2)

**Replacement of Mobile Home for EMS Station in Yemassee**

**Moved** by Council Member Williams, seconded by Council Member Phillips to approve the purchase of a Mobile Home to replace the mobile home used for the Emergency Medical Service Station in Yemassee and authorize \$30,000 (thirty thousand dollars) to be used from the Contingency Fund to do so.
