# MR. GREGG BRUNSON, VICE PRESIDENT, BRUNSON CONSTRUCTION COMPANY, INC., REGARDING BRUNSON CONSTRUCTION COMPANY AND ITS ABILITY TO SERVE AS CONSTRUCTION MANAGER FOR THE UPCOMING CAPITAL PROJECTS SALES TAX (CPST) PROJECTS:

Mr. Gregg Brunson, Vice President, Brunson Construction Company, Inc., came before council regarding Brunson Construction Company and its ability to serve as Construction Manager for the upcoming Capital Projects Sales Tax (CPST) Projects. Mr. Brunson thanked council for the opportunity to come before them. He informed council that Brunson Construction was capable and eager to perform as Construction Manager. He gave a brief history of the company and the works that they have completed in Hampton County. He referenced that they use local contractors and sub-contractors. # HONORABLE T. C. SMALLS, SHERIFF, HAMPTON COUNTY, REGARDING SHERIFF'S REPORT:

Honorable T. C. Smalls, Sheriff, Hampton County, was not present.

# HONORABLE CAROLYN WILLIAMS, CHIEF MAGISTRATE, HAMPTON COUNTY, REGARDING EMPLOYEE'S CLASSIFICATION, TELEPHONES, VICTIM'S ADVOCATE:

Honorable Carolyn Williams, Chief Magistrate, Hampton County, came before council regarding employee's classification, Judge Williams requested that her Clerks be given the same Grade or classification instead of having two different classifications of Grade 8 & 9. She explained that in the past one clerk handled receptionist duties, but now, both Clerks perform the same tasks. She requested that council change and place both clerks at the same classification. Judge Williams also requested that all phones for the Judge and Clerks be provided by the county. She stated that it is not proper for clerks to use their cell phones for county business. She stated that they are mandated seven days of the week to be on call; when a clerk is on call, she stated that she did not feel that it was right for a clerk to use her personal phone, because if a phone was subpoenaed, their personal calls, information would be reviewed also. Judge Williams stated that the county receive funding for the Victim's Advocate Program and those funds

are supposed to be distributed among the Solicitor's Office, the Sheriff, Detention Center, Clerk of Court and Magistrate's Office. Judge Williams stated that her office has never requested any funds from that funding, but to purchase the phones, etc. she is requesting a portion of the funding. Administrator Graham stated that the county does receive approximately \$30,000 (thirty thousand dollars), but those funds are used to pay the Victim's Advocate and Secretary. Judge Williams stated that those funds are not to be used in just one department. Council Member Williams stated that he did not think it was fair for the classifications to be different and doing the same work. **Moved** by Council Member Williams, seconded by Council Member Hollingsworth, to classify the clerks at the same Grade up. Council Member Phillips stated that he felt that they needed to wait until the fiscal year. Council Member Hollingsworth reminded council that they did not wait until the budget in upgrading the position in the mechanic shop. Council Phillips asked where the funds would come from. Administrator Graham stated that she would take it from where council directed her. She stated contingency fund, there has not been any designations from contingency. Council Member Hollingsworth stated that it was a couple of months before the end of the fiscal year when they upgraded the position in the mechanic shop. Council Members Hollingsworth and Williams voted in favor and Council Members Gray, Haulsee and Phillips voted against. Chairman Gray stated that the motion failed for a lack of a majority.

Motion carried unanimously. Mr. Trip Lawton, Chairman, Hampton County Planning Commission, stated that the commission was recommending that council reduce the number of commission members from nine (9) to seven (7). He stated that they were having problems getting a quorum to attend business. He stated that they presently have four (4) members and ask that three (3) be appointed. Council Member Williams stated that the commission was not meeting, because of attendance. He stated that he was looking at a list of nine (9) well-qualified applicants that have desired to come. He stated that this all came up this past March. Is there a stipulation to dismiss people if they are not attending, etc.? Council Member Hollingsworth stated that the Planning Commission was a very important commission. He stated that it should be a diverse commission and all areas to be represented. He stated that when this commission was formed; he was sure there was a reason for the nine (9) members. Council Member Hollingsworth stated that it could still be the nine and could change if attendance was a problem.
