ADOPTION OF THE AGENDA

ADOPTION OF THE SEPTEMBER 16, 2019 HAMPTON COUNTY MEETING AGENDA AND CONSENT AGENDA:

Chairman Bishop asked for a motion to adopt the agenda. Moved by Vice Chairman Phillips, seconded by Council Member Hollingsworth, to approve the September 16, 2019 county council consent agenda and the meeting agenda. Motion carried unanimously.

Chairman Bishop recognized Representative Williams, District 122, South Carolina House of Representatives.

PUBLIC COMMENTS

MR. JIM BROWN REGARDING THE NEED FOR CHAPLAINCY IN HAMPTON COUNTY:

Mr. Brown came before council and reminded council that he had come before them last year in regards for the need of a chaplaincy program in Hampton County. He explained that since that time he has established a non-profit to provide services in the Estill, Hampton and Hopewell areas. He presented a letter to council. He explained that the non-profit started on September 3, 2019. The name of the non-profit is Chaplain 59 of the Lowcountry. Council thanked Mr. Brown for his presentation.

REPRESENTATIVE SHEDRON WILLIAMS, DISTRICT 122, SOUTH CAROLINA HOUSE OF REPRESENTATIVES:

Representative Williams came before council to mention a few things. He asked about the Brunson zoning and if a family is not in the town limits of Brunson, do they have to join the Lowcountry Regional Water System,; when the system was started; residents were told that if they were not in the town limits and were not on the system, they did not have to join, but he said that he would mention it and also there to support Mr. Hutto on the Palmetto Palace project. Council thanked Representative Williams.

PRESENTATION(S)

MS. SANDRA LIGON, SOUTH CAROLINA HUMAN AFFAIRS COMMISSION:

Ms. Sandra Ligon, Human Relations Consultant, South Carolina Human Affairs Commission, came before council to reintroduce herself and to ask that the Hampton County Human Relations Board that was once vibrant get active again. The Chair who was Corrin Bowers could no longer serve since he had other duties as Mayor. Council thanked Ms. Ligon for her presentation.

MR. BRANTLEY STRICKLAND, PROJECT MANAGER FOR HAMPTON COUNTY, SOUTHERNCAROLINA ALLIANCE:

Mr. Strickland came before council and gave the quarterly report for SouthernCarolina Alliance.

MR. JACK HUTTO REGARDING PALMETTO PALACE, MOBILE HEALTH UNIT:

Mr. Hutto, Hampton School District 1, came before council and made a presentation regarding Palmetto Palace, a mobile health unit. He explained that Dr. Yolanda Gibbs and Ms. Eleanor Murray were not present tonight. He explained that the mobile unit serves students that have no insurance or are underinsured. It will also serve those with insurance; Mr. Hutto commented that they are not out to compete with any other health providers. Mr. Hutto informed council that they have one of the sites at Fennell Elementary School but is looking for another site. Council informed Mr. Hutto that the site at the council on aging senior center may be available as a site. Council thanked Mr. Hutto for his presentation.

APPOINTMENT(S)

HAMPTON COUNTY ZONING BOARD OF APPEALS:

Council voted by ballot to appoint Brian McDaniel and Sam Tracy to the Hampton County Zoning Board of Appeals.

RESOLUTION(S)/PROCLAMATION(S)

HAMPTON COUNTY PUBLIC FACILITIES UPGRADE (SENIOR CENTERS):

Moved Council Member Williams, seconded by Council Member Hollingsworth, to adopt the Hampton County Public Facilities Upgrade (Senior Centers) Resolution with the correct wording. Motion carried unanimously

FRIENDS OF THE ARTS BYLAWS:

Moved by Vice Chairman Phillips, seconded by Council Member Williams, to adopt the Friends of the Arts Bylaws by resolution. Council Member Winn asked that it be a part of record that the county is not owners of the building and that they are recreating the Friends of the Arts as a new entity and that this is out of order and not pertinent. Motion carried with Council Members Hollingsworth, Phillips and Bishop voting in favor. Council Member Winn voting against and Council Member Williams abstaining.

ORDINANCE(S)

SALE OF THE RUTH JONES DIALYSIS TO HAMPTON REGIONAL MEDICAL CENTER:

Council Member Hollingsworth explained that he would recuse himself and step out of the room, because he is a member of the Hampton Regional Medical Center Board., Administrator Dobson Elliott explained that the county received a loan from USDA in the amount of \$300,000 to purchase the building; the building cost the county \$240,000 and the \$60,000 is still in the bank. The county is going to sell the building to the hospital for \$240,000 and the remainder that is the bank will be used to pay off the USDA loan. Council asked if there was any interest. Administrator Dobson-Elliott explained that the first payment is not due until January. Chairman Bishop explained that he should have a written statement at the beginning of the meeting. Council Member Hollingsworth commented that he just found out that it was on the agenda. Chairman Bishop commented that it was on the agenda that was sent out. **Moved** by Vice Chairman Phillips, seconded by Council Member Williams, to give first reading to the Ordinance Regarding the Sale of Ruth Jones Dialysis to Hampton Regional Medical Center. Motion carried with Council Members Bishop, Phillips and Williams voting in favor and Council Member Winn voting against. Council Member Hollingsworth recused himself.

USDA – BOND FOR HANGARS ORDINANCE:

Administrator Dobson-Elliott explained that the loan is for 2,666,620 (Two million, six hundred sixty-six thousand, six hundred twenty dollars) for the hangars at the Hampton County Airport.

She asked the first reading be given by title only and the details will be provided at the next reading. She explained that the interest rate would not exceed 3.5%. Chairman Bishop restated that the interest rate cannot be more than 3.5%. Council Member Winn had questions regarding the contingency. Administrator Dobson-Elliott explained that the 10% contingency was included in the 2,666,620 amount. **Moved** by Council Member Hollingsworth, seconded by Vice Chairman Phillips, to give first reading by title only to and Ordinance to Provide for the Issuance and Sale of Not Exceeding \$2,666,620 General Obligation Bonds and Not Exceeding \$2,666,620 General Obligation Bond Anticipation Notes of Hampton County, South Carolina for the Purposes of Defraying the Costs of Acquiring and Constructing the Hampton County Airport Hangar and Other Public Uses; To Provide for the Payment Thereof and Other Matters Relating Thereto. Motion carried with Council Members Bishop, Hollingsworth, Phillips and Williams voted in favor, and Council Member Winn voted against.

Chairman Bishop explained that the County Attorney met with council earlier but had to leave.

Report on Coroner's Lawsuit

Council Member Winn explained that the lawyers presented the proposal and the Administrator said that she supported it. Council Member Williams commented that he supports the ruling of the ruling by the Judge and also reminded council that Administrator Dobson-Elliott recommended the proposal that was worked out. Motion carried with Council Members Bishop, Hollingsworth and Phillips voting in favor and Council Members Williams and Winn voting against.
